## Worldwide Footwear Factory

Vietnam recorded a healthy increase in production along with labor employment in 2022. Compared July 2021 to July 2022, shoes and leather production has risen by 25.5%, while the labor utilization index has surged by 21.6%.

In the first half of 2022, Vietnam's export turnover on leather goods and footwear achieved USD 13.81 billion (14.2% increase), which included shoes export of USD 11.79 billion and bags export of USD 2.02 billion.

USA and EU were the two largest shoes and leather goods export markets for Vietnam in the first 6 months of 2022, which accounted for over 9.3 billion USD. China remained the largest import market, accounting for 63.4% of the machinery and 33.1 % of leather. Other countries such as Thailand, India, Argentina, Mexico, and Pakistan have recorded strong growth in imports to Vietnam.

The Regional Comprehensive Economic Partnership (RCEP) became effective at the start of 2022 and covers about one-third of the world population. Being part of the RCEP, Vietnam is expected to be one of the most beneficial countries, according to the World Bank report.
